# 12.01 OFFENSES ENDANGERING PUBLIC SAFETY

- 1) Firearms and Bows.
  - a) Safe Use and Transportation of Firearms and Bows. Wisconsin Stats. 1987-88 §§167.30 and 167.31 are hereby adopted and incorporated by reference herein, exclusive of their penalty provisions.
  - b) Town Owned Lands. Discharging of firearms and bows is absolutely and totally prohibited on any and all lands owned by the Town.
  - c) Reckless Use. Wisconsin Stats. 1987-88 §941.20 is hereby adopted and incorporated by reference herein, exclusive of its penalty provision.
- 2) Throwing or Shooting of Arrows, Stones and Other Missiles Prohibited. No person shall throw or shoot any object, arrow, stone, snowball or other missiles or projectile, by hand or by any other means at any other person or at, in or into any building, street, sidewalk, alley, highway, park, playground or other public place within the Town of Hustisford.
- 3) Burning of Trash Prohibited. No person shall kindle or cause to be kindled any fire in or upon any street, alley, public way, park or any public ground within the Town of Hustisford.
- 4) Sale and Discharge of Fireworks Restricted. Sec. 167.10, Wis. Stats., regulating the sale and use of fireworks exclusive of any penalty imposed thereby is adopted by reference and made a part of this section as though set forth in full.
- 5) Obstructing Streets and Sidewalks Prohibited. No person shall stand, sit, loaf, loiter or engage in any sport or exercise on any public street, sidewalk, bridge or public ground within the Town in such manner as to prevent or obstruct the free passage of pedestrian or vehicular traffic thereon or to prevent or hinder free ingress or egress to or from any place of business or amusement, church, public hall or meeting place.

# 12.02 LOUD AND UNNECESSARY NOISE PROHIBITED.

No person or business shall make or cause to be made any loud, disturbing or unnecessary - , sounds or noises such as may tend to annoy or disturb a person of ordinary sensibilities in or about any public street, alley or park or any private residence.

Operation of Motor Vehicles. No person shall operate a motor vehicle so as to cause the tires thereof to squeal, the horn to blow excessively or the motor to race excessively.

### 12.03 FISHING FROM BRIDGES.

Fishing from public bridges is absolutely and totally prohibited. [See also §12.01(5).]

### 12.04 CURFEW.

No child 17 years of age or under shall loiter, idle or remain, and no parent or guardian shall knowingly permit his child or ward of such age to loiter, idle or remain in or upon any of the streets, alleys or public places in the Town between the hours of 11:00 p.m. and 5:00 a.m. unless such child is accompanied by a parent, guardian or some person of lawful age having legal custody of such child. This subsection shall not be construed to prohibit such child from performing an errand or duty if directed by his parent or guardian or of urgent necessity or from pursuing the duties of his employment in an expeditious and orderly manner or from going to or from places of business or amusement or private homes.

## **12.05 OPEN INTOXICANTS IN PUBLIC PLACES.**

- 1) No person shall consume any intoxicating liquor or fermented malt beverage while in or upon any street, alley, side¬walk, thoroughfare, parking lot or other public way.
- 2) All purchases of intoxicating liquor or fermented malt beverages IDY the glass or in open containers shall be consumed upon the licensed premises where served and shall not be removed to the public areas set forth in subsection (1) above.
- 3) No person shall possess any glass or open container containing intoxicating liquor or fermented malt beverages in or on any public area set forth in subsection (1) above.
- 4) The license committee of the Town Board may in special circumstances, where it is satisfied that adequate supervision and police protection exist, and upon application therefor by any person, may recommend that the Town Board permit the consumption or possession of intoxicating liquor or fermented malt beverage contrary to this ordinance, provided said permission is limited to a specified time and location.
- 5) Penalties. Any person who shall violate the provision of this section, or any part thereof, shall be punished by a forfeiture of not less than \$10.00 nor more than \$100.00 for each offense, together with the costs thereof and in default of payment thereof shall be imprisoned in the county jail for a term not exceeding thirty (30) days.

# 12.29.288 to 12.948.16 OFFENSES AGAINST STATE LAWS SUBJECT TO FORFEITURE.

#### 12.999 PENALTIES.

Any person who shall violate any provision of this Ordinance shall upon conviction thereof be punished as follows:

- For a violation of §12.04 of this Ordinance he shall forfeit not more than \$25.00 and the costs of prosecution and in default of payment of such forfeiture and costs of prosecution shall be imprisoned in the county jail until the forfeiture and costs of prosecution are paid, but not exceeding five (5) days, provided that for a first offense any person 18 years of age or under who shall be found violating the provisions of said section shall be warned of the penalty for such violation by any police officer of the Town and shall be taken and delivered to the custody of the person having legal custody over him and for a second or subsequent offense he shall be dealt with according to the provisions of Ch. 48 of the Wisconsin Statutes.
- 2) For a violation of any other provision of this chapter, he shall be subject to a penalty as provided in §15.06 of this Code.
- 3) In addition to any penalty imposed for violation of §12.943.01(1) of this chapter, any person who shall cause physical damage to or destroy any public property shall be liable for the costs of replacing or repairing such damaged or destroyed property. The parent or parents of any unemancipated minor child who violates §12.943.01(1) of this chapter may also be held liable for the cost of replacing or repairing such damaged or destroyed property in accordance with §895.035 of the Wisconsin Statutes.
